2020 BOURSE POLICY - Keep this top part for your reference!

- I. All dealers must be at least 18 years old and agree to comply with all local, state and federal laws.
- 2. <u>NO</u> bourse table may be "sub-let" or shared without prior permission of the Bourse Chair. Also, dealers will <u>not</u> be permitted to change table configurations or use tables that are unoccupied.
- 3. Dealers are responsible for providing their own display cases & lamps.
- 4. All dealers will be provided with badges. These badges <u>MUST</u> be worn at all times while the dealer is in the Bourse Area.

 <u>NO ONE</u> will be permitted behind bourse tables without a dealer's badge. In addition, dealer badges will be issued <u>ONLY</u> to the individuals listed on this application. <u>NO</u> additions to the list will be allowed and each dealer is limited to only four (4) badges per application.
- 5. All tables will be assigned by the Bourse Chair on a "First Paid First Served" basis. Returning dealers, however, will be given priority provided their bourse fee has been paid in full by May 1st. Others can reserve their place with a \$50 deposit with full payment due by May 1st.
- 6. Security will be provided for the duration of the show, starting at 10AM, on Friday, 6/19/2020 and lasting until 4PM Sunday, 6/21/2020. Security will do all that is reasonable to prevent theft or robbery during the show but is not financially responsible for any losses. Each dealer will be responsible for his/her own merchandise and agrees not to hold The Stanislaus County Coin Club, the Modesto Clarion Conference Center, the Bourse Chair or any officers, members or associates of the prior listed organizations, liable or responsible for any loss, theft, damage or injury to person or property during the duration of the show. Each dealer is responsible for his/her own insurance.
- 7. Dealer Set-Up is from at 10AM, Friday, 6/19/2020, until 1PM. We will be open to the public on Friday. Public hours will begin at 1PM and close at 6PM. Dealers can continue setting up on Saturday, 6/20/2020, at 8AM until 9AM, with "Visiting Dealer" and club members allowed in from 9AM to 10AM. and setup is from 9AM to 10AM, Sunday, 6/21/2020. Public hours will begin at 10:00AM each day and will continue until 5PM on Saturday 6/15/2020 and until 4PM on Sunday, 6/16/2020.
- 8. During dealer set-up times only dealers with tables & dealers who have purchased "Visiting Dealer Badges" and Stanislaus County Coin Club Members (with name badges) will be allowed in the Bourse Area. "Visiting Dealer Badges" can be purchased for \$20 each.
- 9. Refunds for cancellations must be requested and are not automatic. All refunds must be approved by the Bourse Chair.
- 10. The Bourse Area has been designated as a NO SMOKING AREA and no pets are permitted.
